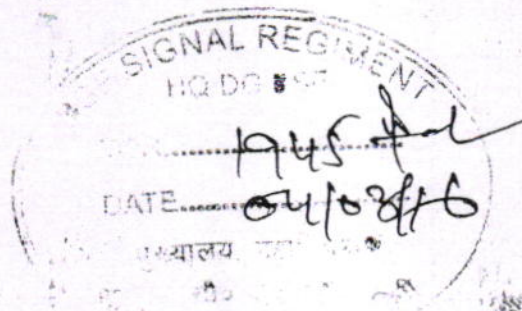


OFFICE MEMORANDUM
