3. Merit of candidates qualified all events/stages of examination has been prepared on the basis of marks obtained in written Test and Interview. In case where more than one candidate have secured equal marks, the tie case has been resolved by applying following methods one after another till the tie has been resolved.

i) Date of Birth – Candidate older in age has been placed higher in merit.

ii) Alphabetical order – The tie is finally resolved by referring to the alphabetical order of names i.e. a candidate whose name begins with the alphabet which comes first in the alphabetical order gets preference.

4. Candidates of SC/ST & OBC category who have not availed any relaxation of their category and came in merit of unreserved category have been adjusted against vacancies of Unreserved category. If SC/ST & OBC Category candidates availed any relaxation of their category, they have been adjusted against the vacancies of their respective category.
