Sealed Bids are invited from authorized bidders (authorized/registered by J&K State Forest Department) for cutting and carrying of poplar trees standing in BSF campus Bandipur as per following details:

- Each participant/bidder shall have to deposit Rs. 1,00,000/- (Rupees One Lakh only) (Refundable) as bid security in the form of Bank draft in the name of DIG SHQ BSF Bandipur. The bid security will be returned to unsuccessful bidders on finalization of auction process. However ED of successful bidder will be retained till compilation of contract and adjusted as security money deposit.
 - Highest successful bidder will have to cut and carry auctioned poplar trees from BSF campus under his own arrangement. No transportation will be provided for shifting/lifting of auctioned poplar trees
 - The safety and security of men and material of BSF will have to be ensured by the successful bidder before and during cutting of trees.
 - Responsibility of provision of equipment , machinery and manpower required for cutting /transportation of trees shall solely rest with successful/highest bidder .
 - The safety and security of manpower/machinery to be utilised for cutting and removal of cut trees will solely be that of the bidder and BSF in no case will be held responsible for any mishap/injury/loss to any individual/machinery employed by the bidder for the purpose.
 - The character & antecedents of persons employed for the purpose should be got verified from the Police by the successful bidder and he will be equally responsible for any act or omission of these persons.
 - The interested bidders may visit the campus, after prior permission, to see/chechtrees before submitting their bids.

9. Auction will be held as per department at Rules and Regulations.
10. Encumbrance of any tax liability will not be the responsibility of BSF. Auction money plus Sales tax/GST with applicable surcharge, if any, will have to be deposited on acceptance of bid lot not later than 02 days and before start of cutting of trees by the highest bidder.
11. The Poplar trees will be auctioned on "AS IS WHERE IS BASIS".
12. In case the highest bidder fails either to deposit the contract amount within 02 days from finalization of contract or lift the cut Poplar trees from the site within the stipulated time of the 30 days, the earnest money adjusted as SMD will be forfeited i.e. will not be refunded.
13. DIG SHQ BSF Bandipur reserves all rights to accept/reject the bid without assigning any reason.
