PERSONAL BANKING
REVISIONS IN FEATURES OF PARAMILITARY SALARY PACKAGE (PMSP)

As part of our commitment to keep improving our PMSP offer to the Forces on an ongoing basis, we are pleased to advise you of the undernoted revisions:

- The Personal Accident Insurance cover which was earlier not provided for the Silver variant of PMSP i.e. PBORs, has now been introduced for this category as well. The cover amount will be Rs 2.5 lacs and will cover accidents as well as death due to terrorism.
- The charges for remittances from PMSP accounts through Core, which were levied on the beneficiary accounts for amounts more than Rs 20,000/- have now been waived.
- Overdraft facility equal to 2 months' salary will be available to the Platinum category from the time of opening the PMSP account.
- The threshold limit for transferring funds from PMSP accounts via Auto Sweep to Multi Option Deposits has been raised from Rs 5,000/- to Rs15,000/-. This was done at the request of many individuals from the Armed Forces who felt that the threshold limit of Rs 5,000/- was too low and led to too many unnecessary debit and credit entries in the account.
- Platinum Account holders are now eligible for International Platinum Debit Cards which bring with them features like (i) daily cash withdrawal limits of Rs 1,00,000/- (or USD 2,000/-) instead of Rs 50,000/- (USD 1,000/-) which was available on the International Gold Debit Cards (ii) higher Personal Accident Insurance cover of Rs 5,00,000/- in lieu of Rs 2,00,000/- available earlier on the International Gold Debit Cards.(iii) These cards will be issued free of cost.

2. We request you to (a) advise the various Command HQs as well as the Units under their jurisdiction of the above benefits and (b) arrange to upload these revisions on your intranet to enable your employees to benefit from them.
