Sir,

Kindly refer to DIG(IT) CRPF Dte CGO Complex letter No.C. VII.1/2013-ITW/R&D dated 30.01.2012 addressed to this office and copy endorsed to all CWOs.

2. In the Apex Body meeting held on 25.07.2012 under the Chairmanship of Chairman(WARB)-cum-DG ITBP, it was decided that IT Wing of all CAPFs will time to time feed the data of retirees of their respective forces in WARB Website in consultation with DIG(IT) CRPF & WARB Central Office. Accordingly as on date data of 1,05,957 Ex- CAPFs personnel are available with IT Wing of CRPF.

3. In this connection it is submitted that the data being provided by CAPFs is not containing proper & complete latest correspondence address and existing contact number of Ex-CAPFs personnel resulting this office is facing difficulties for providing the data of Ex-CAPFs personnel to the willing agency/MNCs for re-employment. This data is also not containing the specific details whether the Ex-CAPFs personnel is willing for re-employment or otherwise.

4. Hence to overcome all these issues mentioned above following are requested :-

I). All CAPFs are requested to detail a Nodal Officer (also desired by DIG IT CRPF) for uploading of data of Widows/Wards of CAPFs Personnel died in harness, medically boarded out and Ex- CAPFs personnel of respective CAPFs with consultation & under overall supervision of DIG(IT) CRPF for further uploading in WARB Website & If needed training may be also imparted to the Nodal Officer to facilitate smooth uploading of data as intimated vide DIG(IT) CRPF letter under reference.



A proposed prescribed proforma, is also attached as Appendix-A & B which should mandatory be filled by the Widows/Wards of CAPFs Personnel died in harness, medically boarded out and Ex- CAPFs personnel willing for re-employment and the consolidated data of only such willing Widows/Wards/Personnel may be compiled and provided to IT Wing of CRPF by respective CAPFs for further uploading in WARB Website for taking effective steps for providing welfare and rehabilitation/re-employment to Widows/Wards/Ex-CAPFs Personnel. Suggestions/views in respect of proposed proforma if any may be intimated to this office immediately for taking suitable corrective measures please.

In addition to this, the data of ex-CAPFs personnel (as referred in para-2) in existing proforma are also required to be maintained properly on monthly basis by all CAPFs for further compiling the same by DIG(IT) CRPF for uploading on WARB Website & soft copy of compiled data may also be sent to this office for record and taking further necessary action please.
